Our Holiday Skip-A-Pay program puts cash exactly where you need it most – in your pocket. To help with your holiday budget, Beach Municipal FCU is offering a Holiday Skip-A-Pay on select loans. Skip your payment and use the money to add some extra cheer to your celebrations!

Qualifying loans may skip either the December 2025 or January 2026 loan payment. If you choose to skip a payment, interest will continue to accrue daily during the month you choose to skip, and your loan may be extended beyond its scheduled payoff date. Members with Guaranteed Asset Protection (GAP) should note that more than two skipped payments during the life of your insured vehicle loan may affect GAP insurance claims. You may skip a payment on more than one loan, but this offer does not apply to First Mortgages, Workout Loans, or Credit Cards. Loans that have already received extensions or modifications this year may not be eligible. If your loan payment is made by payroll deduction/direct deposit, the payment amount will be deposited into your account and will resume as normal the following month.
